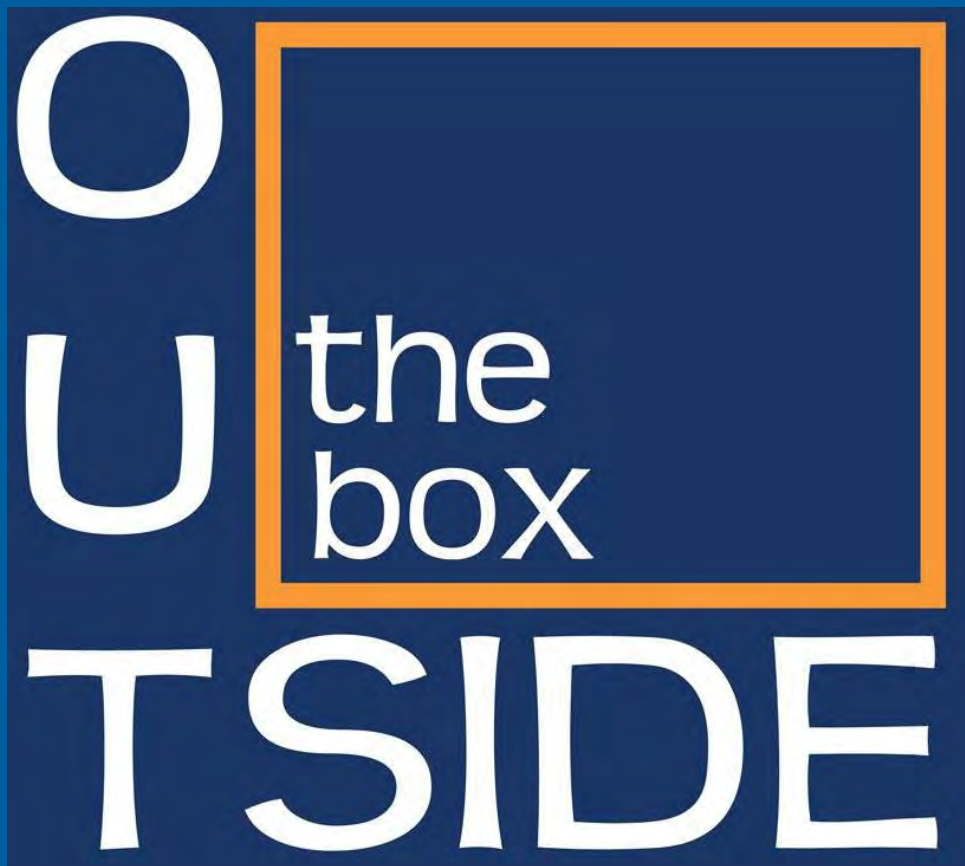


OUTSIDE THE BOX'S

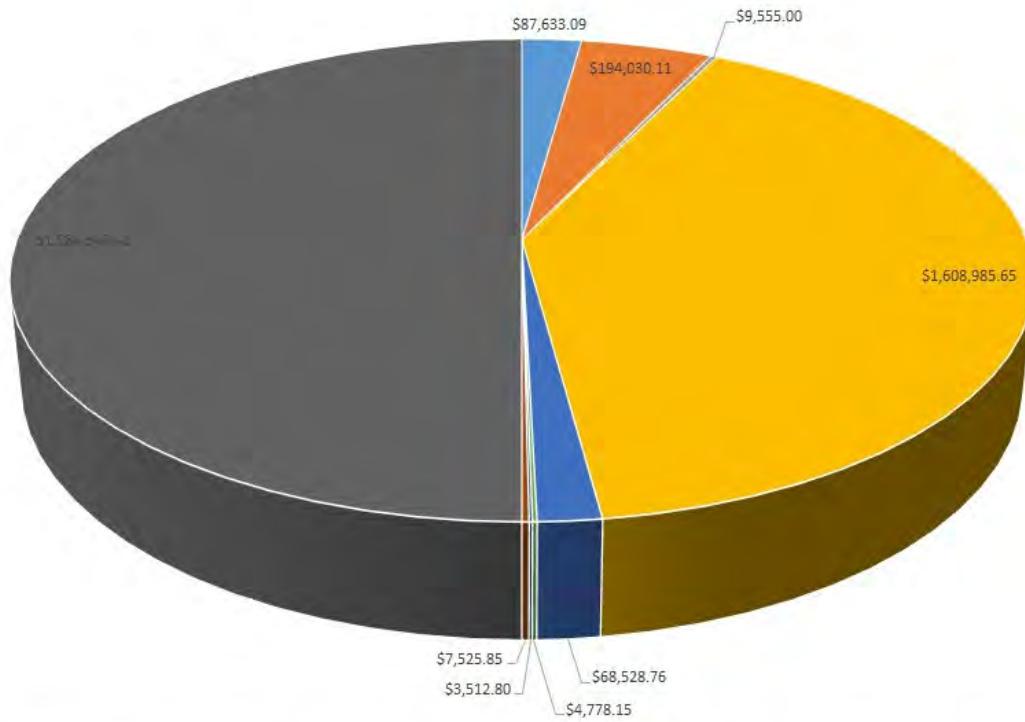

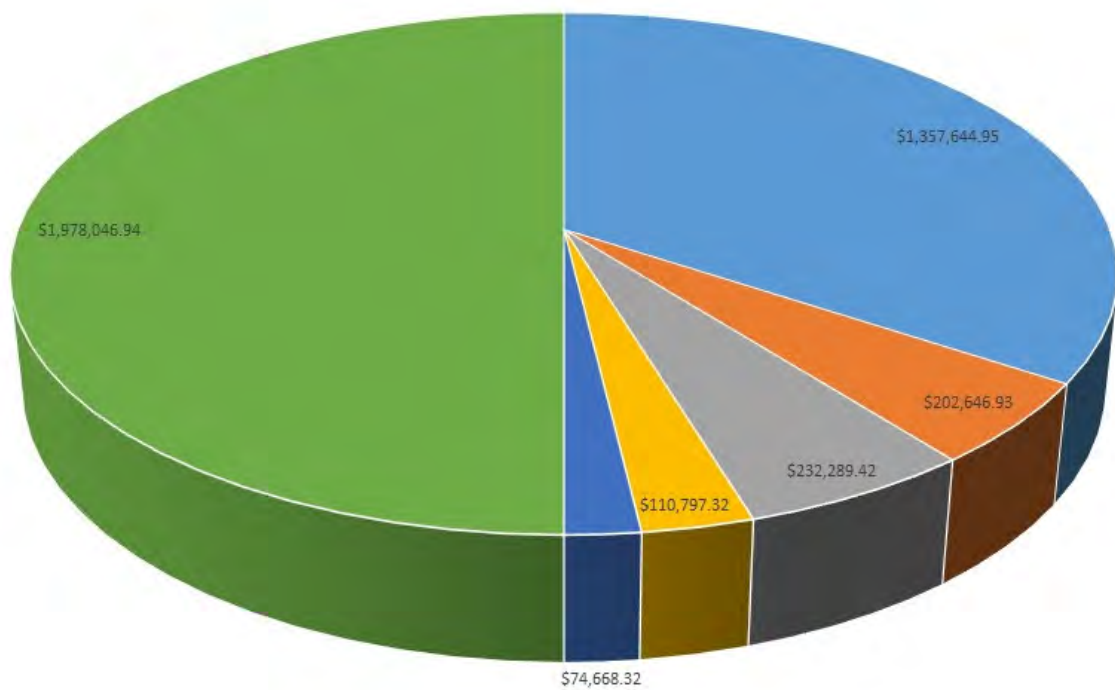


2017 Revenue
